

Zorra Arena COVID-19 Protocols Effective November 23, 2020



The Township of Zorra remains committed to providing a safe and positive experience for user groups. Staff will continue to follow guidance issued by Southwestern Public Health and orders from the Province of Ontario. Renters and organizations are responsible for adhering to this policy. Deliberately non-compliance with this policy may result in cancellation of ice time(s).

As of Monday November 23, at 12:01 a.m., Zorra Township along with the Southwestern Public Health Unit are moving into Orange “Restrict - intermediate measures” by the Province of Ontario. The provincial framework document be accessed through the links below:

The Township of Zorra’s arenas will remain open with the following precautions:


General Precautions:

- A maximum of 50 visitors are permitted per scheduled ice time
- Access to the facility is limited to participants only, including players, coaches, trainers and referees. Spectators are not permitted.
 - When minors are participating, one (1) parent or caregiver is permitted per minor for supervision. Parents/caregivers are also included in the 50-person capacity.
 - Sports organizations may further restrict access of parents or caregivers if it effects their ability to deliver programs.
- Patrons may only be in the facility for 90 minutes except if engaging in a sport
- Maintain 2 metres physical distance from members of other households.
 - Or 3 metres when participating in physical activities
- All visitors must complete a COVID-19 screening before entry into the facility
- Wash hands or use alcohol-based hand sanitizer frequently.
- Do not enter the facility if you have:
 - Travelled outside Canada in the last 14 days.
 - You have symptoms of COVID-19 or are feeling unwell.
 - Had close contact with a confirm COVID-19 case in the past 14 days.
- All visitors over the age of 2 are required to wear a face covering unless engaged in physical activities or are exempt for medical reasons
- Read and follow posted signs or directions from facility staff.
- Facility bookings will not be processed in-person. Bookings will be coordinated via phone or email only. (519-485-2793 ext. 7223 or booking@zorra.ca)

Arriving and Departing the Arena:

- All visitors must complete the provided COVID-19 screening form for entry:

- Or complete copies available upon entering the building
- The arena doors will be locked until 20 minutes before ice times
- Participants will enter the facility proceeding directly to their assigned dressing room(s)
 - Dressing rooms have a capacity of 10 people per room
 - Parents or caregivers are permitted in the dressing room to assist with equipment. When not assisting they are to wait in the lobby
 - Do not stand in the dressing room hallway, as it is to be kept clear
- Participants along with supervising adults will remain in the dressing room(s) or lobby until the ice and hallway have been cleared and cleaned between groups.
- Once directed by staff participants will go directly to the ice surface and supervising adults will move to the viewing area
- The lobby will be cleared of participants, coaches, supervising adults and their belongings to allow for cleaning by arena staff.
- At the end of the ice time, participants will move directly to their assigned dressing room(s). Supervising adults will clear the viewing area immediately, if not assisting with removing equipment will leave the building through the marked exit
- Participants will have 15 minutes from the end of their ice time to change and exit the facility through the designated exit. Showers will not be available following rentals.
- Please remain physically distanced (2 metres) from members of other households, including in the parking lot while departing.

Sports Restrictions:


- Team sports must not be practiced or played except for training (no games or scrimmage)
- Prolonged or deliberate contact while playing sports is not permitted.
- Leagues must contain no more than 50 participants. If participants in a league exceed 50, the league may divide into smaller groups of no more than 50. Players are not permitted to play against players outside of their league or group.
- Groups or Organizations with storage at the facility must arrange to distribute equipment and uniforms prior to the start of their season. Access to on-site storage will not be available during ice rentals.

This assessment tool must be completed before each visit to a Zorra recreation facility and by each visitor per Ontario Regulation 384/20. It is not to take the place of medical advice, diagnosis or treatment.

Select symptoms if they are new or worsening and not related to chronic or known conditions

- Fever or chills
- Difficulty breathing or shortness of breath
- Cough
- Sore throat, trouble swallowing
- Runny nose/salty nose or nasal congestion
- Decrease or loss of smell or taste
- Nausea, vomiting, diarrhea, abdominal pain
- Not feeling well, extreme tiredness, sore muscles
- None of the above symptoms

4. Have you travelled outside of Canada in the past 14 days?


5. Have you had close contact with a confirmed or probable case of COVID-19?
